on Vendor. The Arts & Craft Vendor/ Exhibitor contract for said "GREEN CORN DANCE" Annual Pow-Wow & Gathering will be subject of the following terms:

- 1. The event will take place July 6, 2019.
- 2. The Vendor/ exhibitor must be/have Native American wares.
- 3. The highest conduct / integrity is expected of all exhibitors in their assigned areas, as well as on the Pow-Wow grounds in general. The consumption of alcohol and / or of illegal substances is prohibited. This policy will be enforced by Pow-Wow security personnel and police.
- 4. The Cheroenhaka (Nottoway) Tribe nor the Cheroenhaka (Nottoway) Indian Heritage FD, will not be responsible for any lost, stolen or damage merchandise, nor shall they assume any responsibility for any PERSONAL INJURY incurred.
- 5. The Cheroenhaka (Nottoway) Tribal Council reserves the right to make all final decisions germane to Pow-Wow functions.
- 6. Electricity will be provided for the Drum Arbor ONLY! Campers will be parked in a designated area. Bring your Generators!
- 7. Raffles from exhibitor's / vendors will not be permitted.
- 8. The Cheroenhaka (Nottoway) Indian Tribe reserves the right to determine the Authenticity and approval of all items entering the Pow-Wow Grounds.
- 9. Each Vendor / Exhibitor is responsible for providing his / her liability insurance.
- 10. Booths will be manned at all times during the operating hours of the Pow-Wow.
