



(Red Hawk The Chief Speaks)




Chief Red Hawk Speaks (Was-ve-kr):

Osiyo and Greetings: As we walk into another New Year, 2022, "Full of Faith" thanking the Creator for HIS continued Favor given to our tribe for the past 19 years, we first extend Kudos and Accolades to our Tribal Council, Tribal Members, Heritage Foundation Board of Directors, Committee Members, and Adopted / Honorary Tribal Members for their support in 2021. Because of your support we could host in 2021, at Cattashowrock Town, two great Powwows. Our Green Corn Dance Powwow in July and our School Day an Intertribal Corn Harvest Powwow in November, both of which were a stunning success. The tourist, visitors, Native Dancers, Drummers, across the states, from the east to west coasts, attending our two powwows were excited to take a break and get out of their homes and visit our 10-ace Powwow Ground after the slowdown of COVID.

As we reflect upon the year that is now behind us, we look forward to a VERY PRODUCTIVE, PROSPEROUS 2022, for the tribe. We need to be mindful that COVID still raises its ugly head; and it is strongly recommended that if you are not vaccinated, get vaccinated to protect yourself and your family from COVID.

### Tribal Genealogist

Elizbeth "Snow Lizard" Gates Furrow is the first tribal member to serve as the Tribal Genealogist for the Cheroenhaka (Nottoway) Tribe, with sister Marie "Silver Moon" Gates Janjua as a Genealogy Research Assistant. In August 2018, she enrolled in the Genealogy Research course at Boston University and earned an "A". In November 2021, Snow Lizard and Silver Moon took a 6-week course and earned their certificate, which gives them the title of Genealogist.

She has a great love for research of history and genealogy and states, "My sister Silver Moon and I became interested in genealogy when we were young girls, as our grandparents traveled to many courthouses and cemeteries back in the day, looking up family names, deeds, wills, and marriage records. They painstakingly hand copied those old documents. We treasure the copies we made of their records, and work diligently to continue their research".

### Department of Historic Resources Site

The Cheroenhaka (Nottoway) Tribe has a new site listed with the Department of Historic Resources (DHR) in Virginia. This site was discovered in 2018 after tree harvesting. Stan Piearsa found artifacts on the surface while walking trails on the tribal land. Later, Wayne Edwards walked the same trail several times picking up artifacts each time. This year, Wayne recorded the finds at DHR and was given a site number for the area where the artifacts were found. The new Tribal Land site number is 44sn0389. We hope to find more sites on the Tribal Land in the near future. Stay tuned.

# Tribal Secretary Hired By the Center For American Health at John Hopkins

January 4th 2022, Caroh Holley accepted a position as a Sr. Grants and Contracts Analyst at Johns Hopkins University (JHU) Bloomberg School of Public Health in the Center for American Indian Health. CAIH focuses on partnerships with American Indian and Alaska Native communities to co-design programs to achieve optimal health and wellbeing, raise health status, self-sufficiency and leadership to its highest

potential. Main projects to CAIH are Sexual and Reproductive Health, Adolescent Health, Alcohol and Drug Abuse Prevention, Mental Health and Suicide Prevention, Maternal and Early Childhood Health, Infectious Disease, Environmental Health and Entrepreneurship and Workforce Development.

The CAIH has impacted Native Communities for over three decades, including; 1000,000+ American Indian families have been directly served, and 400+ community health workers hired and trained. The Center has also provided over 1000 scholarships to American Indians for public health training at JHU.

Caroh states, "Being of Native American descent, this is a once in a lifetime opportunity for me to work in a department which combines my heritage and passion for my culture and the opportunity to make a difference in indigenous communities".

### Sportswood Treaty Tribute

On April 19, 2021, Chief Walt "Red Hawk" Brown, Chief of the Cheroenhaka (Nottoway) Indian Tribe of Southampton County Virginia, accompanied by other tribal members, presented the 308th Spotswood Treaty Tribute of three peace arrows, wrapped in a Beaver Pelt and wampum belt, to the Governor of Virginia. The treaty is normally presented on Saint George Day.

The Treaty Tribute was presented to the Governor in accordance with the tribe's Treaty of February 27, 1713 between Virginia's provisional Lt Governor Alexander Spotswood and the King of the Cheroenhaka (Nottoway) Indian tribe, Ocoraass Trier aka William Edmond.

As a special place in the tribe's history, as a first, two of the youngest tribal members, Princess Windsong Brown, 8, and Red Eagle Brown, 7, took part in the treaty tribute. Windsong and Red Eagle are the children of Chief Walt Red Hawk Brown. They are students at Meherrin Elementary School.

### The Cheroenhaka (Nottoway) (Archaeological Brief



Cheroenhaka Nottoway Pottery

On October 27, 2014 I visited the Virginia Department of Historic Resources (VDHR) to meet with Dee DeRoach to pick up the "History's Mysteries" archaeology workbooks to pass out at the upcoming Cheroenhaka (Nottoway) Indian Tribal Pow Wows. While waiting for Dee, I visited the office of a fellow Archaeological Society of Virginia (ASV) member, Keith T. Egloff. In the corner of his office was a very large ceramic pot that stood approximately 2.5 feet tall. I had spied it through the glass wall and wanted a closer look. I asked permission to photograph it and immediately noticed three marks in the clay near the rim of the pot. It was the same signature/Chief's mark that appears on the Woodland Plantation Treaty of 1677. I asked Mr. Egloff's permission to inspect the pot without moving it, had to use a mirror for the back view! To my surprise and his we found the very same signature appeared on all

four sides of the rim of the pot at what would be the cardinal points of the compass: North, South, East & West. It is my belief that this was a pot created to be used for official trade/exchange/tribute because it bore the signature of the Chief of the Cheroenhaka (Nottoway) on all four sides. This vessel was recovered from an earthen burial mound.

The information plaque says: "STORAGE JAR" "This large pot was recovered from Conner's Midden in Halifax County Virginia. The maker's signature (three lines in the clay) can be seen near the lip."

#### THE REST OF THE STORY

Conner's Midden was first explored by Henry & Edward Valentine in 1883. R. P. Carrol & John H. Reeves, Jr. explored it in 1953 giving it the name, Conner's Midden. Reeves recorded the site in 1954. Howard A. MacCord, archaeologist with the Library of Virginia, which preceded the creation of VDHR in 1986, investigated the site again in 1968.

Conner's Midden is located on the historic property known as "The Cove" (VDHR #041-5086) which was listed on the National Register of Historic Places on May 11, 2006 & contains 1,123 acres. It is owned by the Walter Burton Wildlife Foundation, P.O. Box 519, Halifax, VA and is situated in north central Halifax Co., along it's boundary with Charlotte Co. within a horseshoe bend of the Staunton River at the end of VA St Rt. 617.

### Federal Recognition Update (Continued January, 2022)

AS mentioned in previous updates, Congressman Scott recommended that our packet, that had been laying dormant in Senator Kaine's office, with broken promises, for more than eight years, would carry more weight should we put forth a combined bill to Congress requesting that the remaining three Virginia State Recognized Tribes be Federally Recognized via Congress in the same manner as the recently six Federally Recognized Virginia Tribes. Prior to this recommendation, we had already reached out to Congressman Donald McEachin, 4th Congressional District Representative; wherein, he agreed to run point in Congress with our packet seeking Federal Recognition. As such, I reached out to the Chief of the Patawomeck Indian Tribe of VA and after explaining that our tribal council was in favor of a combine bill, he agreed. He said he would reach out to the Nottoway, Inc and have them request the same. Some months later, after leaving numerous telephone messages, the Nottoway, Inc., finally agreed via a letter address to Congressman McEachin, singed by their tribal secretary.

Over the past two years, I maintained monthly contact with Congressman McEachin's office, via Blair Wriston, his Legislative Assistance (LA), requesting status updates. I was informed about 12 months ago that our Packet was before the Committee on Natural Resources waiting comment. In December 2020 I received a call from Blair Wriston informing me that a staffer with the Committee on Natural Resources would be requesting a conference call in the future with the three Chiefs or their representatives. I assume this would be a question and answer session; however, it never took place.

After two years, in October 2021, 1 received a letter dated September 17, 2021, bearing Congressman McEachin's signature telling us to submit our packet requesting Federal Recognition to the BIA / OFA, in that Congress does not know how to proceed with the process. This letter was basically a facsimile of the same letter that Senator Kaine sent to us in 2018, shortly after the recent six VA Tribes were federally recognized via Congress. As a result of the letter I set up a conference call with Congressman McEachin's staff which included the Chiefs of the other VA State Recognized Tribes; wherein, I challenged the letter in that as in the six tribes, recently Federally Recognized vial Congress, like them, we could not meet the BIA's requirement proving that we had Tribal autonomy as of 1900 forward due to the Racial Integrity Acts of Virginia and Walter Plecker's negation of tribal communities within Virginia. That is the same reason those tribes decided to seek Federal Recognition through Congress.

After the conference call with his staff, which proved to be fruitless, I had our medial and P/R rep, tribal member, Karen "Running Moon" Barrett to contact Congressman McEachin's scheduler to set up a one on one meeting, with him. I am happy to report that last month I had a one hour Zoom, one on one, meeting with Congressman McEachin. After addressing his letter and explaining the reasons we chose the congressional route he said that he would get back with us.

In the interim, I will continue to compile a packet for the BIA/OFA. I called the OFA and spoke directly with its Director, Mr. Fleming, and requested an updated version of 25 CFR Part 83.



### TRIBAL ADMIN FEES AND TRIBAL LAND MAINTENANCE /TAX FEES

If you have not paid your Admin and Land Maintenance /Tax Fees for FY 2022, please do so as soon as possible. All fees, admin and land are normally due the first quarter of each year.

Admin fees are \$60 per annual or \$15 per quarter for all adult tribal members between the ages of 21 to 65. Land Maintenance/Tax fees are \$100 per annual. Undergrad College or Tec School Students between the age of 18 and 24 is \$30 per annual. Land Tax is waved for college or Tec School students

Admin fees are \$50 per annual or \$12.50 per quarter for all adult tribal members between the age of 66 and 79. Those tribal members that are 80 years and older are not required to pay Admin Fees or Land Tax; however, all donations are welcome.



# About the Graphics



The Three Sisters are the three main agricultural crops of various Native American groups including the Cheroenhaka (Nottoway). Winter squash, maize (corn), and climbing beans were grown together.



This symbol represents the Sky Dome. The design is made with superimposed semi-circles, representing the three levels of the Iroquois cosmos: the Celestial world, our world and the world of darkness. The two volutes (spiral curls) symbolize either the Celestial tree or the life-long struggle between good and evil (represented by the twins) that we all have within ourselves.
